# 2023 REPORT

The Conservancy is driven by a collective community goal: to preserve, protect, and manage the natural environment within the Clear Lake watershed and township for future generations.

It is through the collaboration and support of our generous community and partners that we can carry out this mission. Our gratitude is overflowing as we reflect on all that we have accomplished this past year. Together, we are proud to report that throughout 2023, the Conservancy and our supporters...



Engaged **876 COMMUNITY MEMBERS** through educational and outreach programs, including 4 sessions of Knee-High Naturalists, our Fun Day & Run in July, the Soil and Water Conservation District Conservation Field Day for Steuben County Fourth Graders and public meetings updating progress of our ongoing Water Quality projects.



Invested over **2,560 VOLUNTEER HOURS** to support water quality testing, invasive plant removal, trail maintenance, land stewardship and organizational development. Volunteers include 16 Board members, 31 committee members and countless community supporters.

Received gifts and donations from **321 CONTRIBUTORS**, (56 of them new) with generous responses to the Year End and "Giving Tuesday" appeals and our summer Fun Day & Run, which demonstrated community giving of around 36% of our work. Thank you for your support!



Hosted a community-centered **FUN DAY & RUN** fundraiser with 156 runners participating in a 10K, 5K, or 1-mile walk/run and 30 youth participating in Fun Day activities. With representation from 28 sponsors, over \$50,000 was raised to support the ongoing work of the Conservancy.

Expanded the Legacy Society through additional members, now totaling **9 LEGACY SOCIETY MEMBERS** that have shared the naming of the Conservancy in their will, living trust, or as a beneficiary of retirement or financial accounts.

Gained more than **150 NEW FOLLOWERS** on our social media pages.



Continued the preservation and protection of **100 ACRES OF LAND**, including almost 2 miles of public trails, and set the stage to acquire 45 more acres of land in 2024.

Treated and reduced a major infestation of **EURASIAN WATERMILFOIL** in Clear Lake and Round Lake for a second year.



Gathered data through the **WATERSHED DIAGNOSTIC STUDY**, including full-scale data collection in two major inlets, one major outlet, and multiple point locations to better understand the unique dynamics of sediment and nutrient disturbance in Clear Lake and Round Lake.

Received a grant of over \$59,000 from the **MIDWEST GLACIAL LAKES PARTNERSHIP** and **U.S. FISH AND WILDLIFE SERVICE** to support our Watershed Diagnostic Study for improving water quality and monitoring fish habitat conditions.



Welcomed **NEW EXECUTIVE DIRECTOR**, Caroline Barth, as she brings knowledge of soil and freshwater nutrient cycling and returns to her favorite summer home at Clear Lake.

Accepted a \$4,000 grant from the **LAND TRUST ALLIANCE** to provide up to a 25% cost share of three lake-shore residential projects installing glacial stone and natural shorelines that absorb wave energy, reduce erosion, and protect sensitive habitats.

Grew the five-year old Vanguard endowment fund, named the **FOREVER FUND** by 35%, through generous donor contributions honoring outgoing President, Karen Horrell (the "Honoring Karen" campaign), personal donations and interest earnings.

The Conservancy Sustainers Program continued with generous support from 12 families who donate monthly, providing steady, year-round support for Conservancy operations.
