THE DITCHES FLOWING INTO CLEAR LAKE, ROUND LAKE, AND LAKE ANNE ARE TESTED WITH THE HELP FROM SEVERAL VOLUNTEERS. TESTING SUPPLIES ARE PROVIDED BY THE HOOSIER RIVERWATCH PROGRAM AND THE CLEAN LAKES PROGRAM. DURING THE YEAR, THE CONSERVANCY CONDUCTED A WATERSHED DIAGNOSTIC STUDY. THIS DIAGNOSTIC STUDY WILL ESTABLISH AN EXTENSIVE DATABASE TO IDENTIFY KEY PROJECTS IMPACTING THE HEALTH AND SAFETY OF THE SURROUNDING LAKES AND DITCHES FEEDING THE LAKE.
