Wondering how your donation supports the Clear Lake Conservancy and Community?

Our work focuses on environmental education, water quality improvements, and natural areas preservation. Below are some of the project costs for 2025 that your donation helps fund.

\$20,000	Funding for one advanced sampling station for water testing for one year. This will help us gather the data we need to understand the nutrients and sediments entering our lakes. Data drives our action!
\$15,000	Treating 20 - 30 acres of an aquatic invasive species for one year to mitigate the damaging effects of invasive overgrowth on our lake floor.
\$10,000	Purchasing and forever protecting 1 - 2 acres of sensitive habitat, critical wetlands, or open space.
\$8,500	Funding of one basic sampling station for water testing for one year at the outflow of Round Lake.
\$3,000	Completing aquatic species identification and mapping of Clear and Round Lakes in the spring and fall.
\$2,000	Printing one issue of Clear Thinking newsletter to keep our community engaged in our projects, programs, and environmental updates.
\$2,000	Providing tools and supplies for annual workdays in our growing number of properties.
\$1,500	Funding the printing of the 2025 Conservancy Calendar that highlights the beautiful natural surroundings of our Clear Lake Community.
\$1,400	Providing additional seed planting and maintenance of the prairie at Clear Lake Nature Preserve.
\$1,000	Funding for four sessions of our youth education summer program, Kneehigh Naturalists, and T-shirts for all participants.
\$500	Supporting the appraisal or survey costs for the acquisition of one new property to protect and preserve forever.
\$250	Contributes to the ongoing maintenance of 3 public trails that inspire personal connection with nature and feature educational hikes.
\$100	Providing support to outside speakers for various adult and community educational programs.
