Water Quality

The Water Quality Committee and volunteers have been collecting water sampling data from the lake and the four ditches that drain into the lake for most of CLTLC's existence. Testing parameters include temperature, pH, nitrate, nitrite, E. coli, dissolved oxygen, orthophosphate, biological oxygen demand, and turbidity. This section of *Clear Thinking* will continue to explain these testing parameters.

Biochemical oxygen demand is a measure of the quantity of oxygen used by aerobic bacteria as they break down organic matter. Natural sources of organic matter may include plant decay and leaf fall. However, plant growth and decay may be unnaturally accelerated when nutrients (like phosphorus and nitrogen) and sunlight are overly abundant due to human influence. Surface runoff carries pet waste from streets and sidewalks; nutrients from lawn fertilizers; leaves, grass clippings, and paper from residential areas, which increase oxygen demand.

So, why does this all matter? Oxygen consumed in the decomposition process robs other aquatic organisms of the oxygen they need to live. High levels of organic matter can lead to rapid exhaustion of dissolved oxygen. A healthy, diverse lake system requires ample oxygen for the survival of fish and macroinvertebrates. What can you do to help? Reduce the amount of organic matter making its way into Clear Lake by cleaning up after your pet, properly disposing of lawn waste, and leaving a buffer along the lake when applying chemicals.

Natural Area Preservation

Memorial Woods was donated to the Conservancy in 2009 by Mike and Pat Franz to honor one of the Conservancy's former Board Presidents, Paul Federspiel. Paul died in 2008 and would have delighted in this gift of open space in a community he loved and worked to conserve.



Located between Point Park Drive and East Clear Lake Drive, this 1.6 acre wooded park-like land was also donated by the Franz family as a way to honor the passing of a loved one. Environmental Education

Why are those pretty plants being pulled up? What's the harm to the environment at Clear Lake?

Invasive plants are bullies. They crowd out native plants more friendly to the Clear Lake landscape and water ways. Invasive plants may threaten rare and endangered species and can even change how some ecological systems function. They may hybridize with close native plant relatives. In short, they take over.

Conservationists emphasize early detection and persistent removal. The appropriate treatment is site-specific,



species-specific, and season-specific. Executive Director Bridget Harrison is happy to provide hands-on training on Conservancy properties, as illustrated by recent photos from Brennan Woods and Flora-Hussleman Trumbell Nature Preserve projects.

While there are numerous invasive plants known in Indiana, Bridget points to several troublesome plants often encountered in the CLTLC



region--dame's rocket, purple loosestrife, various honeysuckle varieties, and garlic mustard--and encourages homeowners to monitor their property regularly to catch and remove them early.

The benefit is conservation of biological diversity, natural resource management, and environmental protection of our Clear Lake land and water.

Interested in more information?
