## **Clear Lake Spirit**

The 2017 Conservancy Spiritfest was another remarkable display of Clear Lake community spirit and generosity. A sellout-crowd of over 200 guests enjoyed a beautiful June evening at the Clear Lake Yacht Club on the 24th with tasty cocktails provided by Gay's Hops-N-Schnapps, delicious food from Sutton's and fabulous music by the Jim Steel Trio and the Fort Wayne Funk Orchestra. The Auctions---Silent and Live--offered classic "Clear Lake themed" items and the now traditional auction drama to benefit the Conservancy's priority projects. Don Luepke's auctioneering was lively, fun and entertain-ing! The books are still open but we expect final accounting to net over \$30,000 for the Conservancy.

The center pages of *Clear Thinking* acknowledge our event sponsor, auction donors, bid winners and our volunteers. Thank you to all who helped us continue to build community across the Clear Lake Township population and build financial resources to complete our priority projects with this event.

The Kasota Island Restoration, Brennan Woods Trails and Operating Endowment are each long-range investments in the 13 Conservancy properties and the health of the Clear Lake Watershed. Most big projects look or seem "messy" in the middle. This is an ideal time to bring you up to date on these key initiatives since many of you spend more time here in the summer. Some of you are ask-ing: "Remind me--what's happening at **Brennan Woods** and on **Kasota**? Remind me again--why are we doing these projects?" **See back page for Kasota Island update.** 

Converting the 45 acre **Clear Lake Nature Preserve & Brennan Woods** to its former open oak woodland continuum requires a selective harvest and a prescribed fire. Timber harvesting is used as a management tool to change the light levels in the forest, to stimulate regeneration, and to change the very structure of the forest. It can be controversial, it can be hard to understand, and it can be ugly! Under the direction of a forestry consultant, over the last several months, large equipment has removed carefully selected trees from Brennan Woods and other portions of the Clear Lake Nature Preserve. When timber is harvested, bits of the tree, like the tops, remain, temporary access trails are installed, erosion occurs, and occasionally residual trees are damaged or taken out in the process. Removing these carefully selected trees will help us reach our restoration goal of opening up the canopy to allow more light to reach the forest floor. The prescribed fire earlier in the year helped to remove a thick leaf litter layer, creating more ideal growing conditions for native understory plants.

Working with our summer intern, Jonathan Moss, we are designing a hiking trail through the preserve. Our goal in creating the trail is to help protect important features of the preserve while encouraging exploration and enjoyment of this beautiful property. Let us know if you have ideas for the route and trail design!

## Kasota Island Project Update

The history of Kasota Island was covered in our March 2016 issue of Clear Thinking and many are aware of our upcoming Kasota Island restoration project. We'd like to provide a project update and direct you to additional updates, as they become available, on our website: clearlakeconservancy.org.

Kasota Island is eroding at rate of 3-4 inches per year from wind and wave action, according to a 2016 Feasibility Study. The goal of our 3-phased restoration project is to minimize future erosion. Phase I, now complete, included engineering survey & design plans, and permit applications. After Labor Day, if our permits are granted, we plan to install a bioengineered seawall with vegetation on the north, west, and south shoreline. To give the plants an opportunity to grow, temporary protective fencing will be installed and remain in place for 6 months after installation. The remaining east shore section will be completed in the Fall of 2018.

The island is an important space for wildlife and for our community. The entire shoreline will be protected with glacial stone and multiple access points will be installed. The sandy beach areas that are exposed each summer should still remain. For more specific project details please view the project

brochure and plans available on our website.

We are pleased to announce the recent grant award of \$96,000 from the Lake and River Enhancement Program (LARE) from the Indiana Department of Natural Resources. Phase II funding is now secured with the help of generous community supporters. LARE will only cover up to \$100,000 or 1/3 of the total estimated \$300,000 cost. Phase III funding has not been fully secured.
